ORDER GRANTING INTERVENTION

ISSUED: October 12, 2021

On September 22, 2021, the Utah Association of Energy Users petitioned for leave to intervene in this docket.

Because no party has objected to the petition and good cause otherwise appears to exist, the Public Service Commission (PSC) will grant intervention. Intervention is conditioned upon the intervenor's representatives participating in this matter adhering to the Utah Standards of Professionalism and Civility adopted by the Utah Supreme Court October 16, 2003.
