  - (b) represent oneself individually; or
  - (c) ***if not an individual, represent itself through an officer or employee.***
- (2) An attorney who appears pursuant to Subsection R746-1-107(1)(a)(ii) is not required to:
  - (a) apply for pro hac vice admission to the Utah State Bar; or
  - (b) partner with counsel licensed in Utah.

(emphasis added). Mr. Leger is a full-time employee of Interwest as well as an attorney licensed in Colorado, the District of Columbia, and Wyoming.

- C. Mr. Leger regularly collaborates with other regulatory counsel in Utah and other jurisdictions. The undersigned is committed to adhering to the Utah Standards of Professionalism and Civility adopted by the Utah Supreme Court.
