Pursuant to Utah Code § 54-10a-301, UTAH ADMIN. CODE r. 746-1 and the Public Service Commission of Utah’s (PSC) August 23, 2021, oral order at the close of the hearing in this docket allowing the parties to file post-hearing briefs ten calendar days after the transcript become available, the Office of Consumer Services (OCS) moves for an extension of time for all parties to file their post-hearing briefs until September 27, 2021.

BACKGROUND

On August 23, 2021, the PSC conducted a hearing in docket 21-035-14 on Rocky Mountain Power’s (RMP) application to establish a balancing account for pension losses. At the close of the hearing the parties requested that they be allowed to file a ten-page post-hearing brief on specific legal issues raised in the proceedings. The PSC issued an order allowing the filing of post-hearing briefs due ten calendar days after the transcript of the hearing becomes available. The court reporter filed the transcript on September 8th leading to the briefs to be due on Monday the 20th of September.

However, counsel for the OCS will be out of town the week of the 14th and most of the week of the 20th. Accordingly, counsel for the OCS requested a one-week extension from the other parties in the case to file the post-hearing briefs, making all parties' briefs due September 27, 2021. All parties agreed and, accordingly, the OSC represents that no party objects to this motion. Thus, the OCS moves the PSC to amend the scheduling order to reflect the parties' agreement that post-hearing briefs are now due on September 27, 2021.

The OCS also moves for expedited treatment of this matter. Post hearing briefs are currently due on September 20th and this does not leave sufficient time for the briefing of this motion pursuant to Rule 746-1-301. Moreover, briefing is unnecessary because the motion is not contested. Accordingly, the OCS requests expedited treatment of this motion.
