The Public Service Commission (PSC) initiates this docket in accordance with the PSC's December 30, 2020 Order in Docket No. 20-035-04 to establish a collaborative stakeholder process related to grid modernization and rate design. Various parties requested that Rocky Mountain Power (RMP) submit an informational filing ("Informational Filing") with the PSC to initiate the collaborative stakeholder process, which we find may reasonably allow interested parties to commence collaboration from an informational baseline.

The Informational Filing shall include at least RMP's Advanced Metering Infrastructure (AMI) Project scope and schedule, and RMP's grid modernization and Advanced Rate Design (ARD) plans and schedule generally. RMP's Informational Filing may also include other topics to help frame this docket. RMP shall submit its Informational Filing by **Monday, May 3, 2021**.
