I am providing the following in response to your e-mail request for information pertaining to PacifiCorp's Blue Sky Program. PacifiCorp does business in Utah as Rocky Mountain Power (RMP). The Public Service Commission of Utah (PSC) approved RMP's Blue Sky Program and requires RMP to file an annual report on the Blue Sky Program. This report is reviewed by the Division of Public Utilities (DPU), a state agency, and other interested parties. RMP's 2020 Annual Report of the Blue Sky Program for the period of January 1 through December 31, 2020 (filed on March 25, 2021), the DPU comments on the 2020 Annual Report, RMP's reply comments, the PSC's letter acknowledging the 2020 Annual Report, and DPU's review and audit of PacifiCorp's 2020 Blue Sky Program dated July 29, 2021 can be found at the following link: <https://psc.utah.gov/2020/03/26/docket-no-21-035-21/>

In its comments on the 2020 Annual Report of the Blue Sky Program, the DPU stated the 2020 Annual Report "substantially complies with [PSC] Orders and adheres to the [PSC]'s reporting requirements." DPU requested RMP include community project information, including projects for underserved communities, and the percentage of Blue Sky funds awarded to each project. On May 11, 2021, RMP filed an update to the 2020 Blue Sky annual report and on May 13, 2021, the PSC acknowledged the updated report as complying with the PSC reporting requirements.
