Dear Commissioners:

Rocky Mountain Power (“the Company”) hereby notifies the Public Service Commission of Utah (“Commission”) that it has made certain amendments to the Renewable Resource Contract (“RRC”) between the Company and Castle Solar, LLC (“Seller”) that was previously approved by the Commission on June 25, 2021, to purchase, on behalf of Intermountain Healthcare Services, Inc. (“Customer”), renewable energy output from the Castle Solar electric generation facility located in Emery County, Utah. The RRC was originally submitted by the Company for Commission approval on April 22, 2021, because of its linkage to the Schedule 32 Contract. The Company notifies the Commission that, at Customer’s request and with its approval, Company and Seller amended the RRC with the following modifications:

These changes do not materially alter the original terms of the contract, nor do they alter the RRC contract price, tenor, or energy output of the Castle Solar electric generation facility.


