Dear Ms. Saba:

The Public Service Commission (PSC) reviewed Rocky Mountain Power's (RMP) April 29, 2021 filing of its Fourth Annual Sustainable Transportation and Energy Plan Act ("STEP") Program Status Report ("Report"). The Report was filed pursuant to the PSC's orders in Docket Nos. 16-035-36 and 18-035-16.¹ The PSC also reviewed the June 2, 2021 comments filed by the Division of Public Utilities (DPU) and the Office of Consumer Services (OCS) and RMP's June 17, 2021 reply comments and June 22, 2021 correction to its reply comments.

DPU provides a summary of the PSC's orders in this docket as well as accounting and implementation information for each program. DPU also comments on minor errors in data related to an account analysis for the Utah Solar Incentive Program (USIP). DPU states RMP has complied with the PSC's Orders related to STEP reporting and therefore recommends the PSC acknowledge RMP's Report.

OCS states that the Report generally complies with the reporting template approved by the PSC however the level of detail reported varies greatly from project to project. OCS recommends RMP file supplemental information regarding the Panguitch Solar and Battery Storage Project ("Panguitch Project") with the level of detail similar to that of the Soleil Project. OCS further states certain pages are missing from the Report and recommends RMP file the missing pages if applicable.

In its reply comments RMP provides corrected USIP information and associated work papers, and the omitted pages identified by OCS. Regarding OCS's request pertaining to the Panguitch Project, RMP explains it continues to work with the battery supplier on the battery control system and that it anticipates preparing a final report on the Panguitch Project by the beginning of August 2021. RMP commits to filing the report once it is finalized.

Based on the PSC's review of the Report, DPU's and OCS's comments and recommendations, and RMP's reply comments and reporting commitment, the PSC acknowledges the Report as complying with PSC's relevant STEP reporting requirements.
