Rocky Mountain Power Reply Comments

On August 25, 2021, Rocky Mountain Power ("Company") filed its report on the Panguitch Solar and Battery Storage Project ("Report") in compliance with a commitment it made in reply comments filed on June 17, 2021 in the above referenced matter. The Public Service Commission of Utah ("Commission") issued a Notice of Filing and Comment Period on August 30, 2021 ("Notice") establishing comment and reply comment deadlines. On September 24, 2021 the Division of Public Utilities ("Division") and the Office of Consumer Services ("Office") filed comments in accordance with the Notice. Both the Division and the Office requested the Report be revised to provide additional information. The Division suggests the Company provide the additional information in its fifth and final STEP annual status report due to be filed by April 30, 2022 ("Fifth STEP Report"). The Office recommended the Company file an updated report by the end of 2021 or at a later time if deemed appropriate. The Company commits to address the issues raised by the Division and the Office in an updated report and requests the updated report be required to be included with the Fifth STEP Report, as suggested by the Division, to allow sufficient time to adequately address the issues raised.
