REVISED NOTICE OF **SOLICITAION PROCESS**

Pursuant to Utah Administrative Rule R746-420-1(3)(a) and Utah Code section 54-17-203, PacifiCorp dba Rocky Mountain Power ("RMP" or the "Company") hereby updates and revises the notice it provided to the Public Service Commission of Utah (the "Commission") on August 31, 2021, of its intent to seek approval of a solicitation process under Part 2 of the Energy Resource Procurement Act, Utah Code Ann. Title 54, Chapter 17 ("Notice").

In the Notice, the Company informed the Commission of its upcoming 2022 All Source Request for Proposals ("RFP") for 1,345 megawatts of renewable and non-renewable resources plus approximately 600 megawatts of battery storage, all capable of delivering energy and capacity to PacifiCorp's system for service on or before December 31, 2026. The Company also sought a waiver of the requirement to provide 60 days' notice of its intent to file the 2022 All Source RFP. On October 4, 2021, the Commission granted the Company's motion to deviate from the 60-day rule.

The Company initially planned to file the 2022 All Source RFP on October 20, 2021, due

to the timing of PacifiCorp Transmission's interconnection cluster study schedule as well as the

regulatory requirements and milestones for the solicitation process. Specifically, the Company

sought to determine a shortlist before the close of the cluster study process, the window for which

closes on May 16, 2022. Since the Company filed its Notice, it has determined that sufficient

options exist for bidders to participate in PacifiCorp Transmission's annual cluster study before

they have been selected as a resource through the 2022 All-Source RFP, and therefore the

Company does not need to file its 2022 All-Source RFP on October 20 as planned. The Company

anticipates that it will file the 2022 All-Source RFP on or around January 7, 2022. This filing

constitutes the Company's notice to the Commission that it intends to conduct this solicitation

process, as required by Utah Administrative Code R747-420-1(3)(a).
