*Courtesy Update to Revised Notice of Solicitation Process*

On October 8, 2021, Rocky Mountain Power (the “Company”) filed a revised Notice of Solicitation Process regarding the Company’s solicitation process for the 2022 All Source Request For Proposals as required by Utah Administrative Code R746-420-1(3)(a) (“October 8 Notice”). In the October 8 Notice, the Company anticipated it would file the 2022 All-Source RFP on or around January 7, 2022. The Company notes that R746-420-1(3)(b) requires a pre-issuance bidders’ conference be at least 15 days prior to the filing of the solicitation process, which would put the timing of this requirement during the holidays. The Company wishes to inform the Commission that in consideration of this and to facilitate attendance by interested persons, the Company will hold the pre-issuance bidders’ conference on January 11, 2022 and the 2022 All-Source RFP will be filed on January 26, 2022.
