Notice of Update to Schedule in 2022 All Source RFP

On January 26, 2022, PacifiCorp filed its 2022 All Source Request for Proposal ("2022AS RFP") in the above referenced docket. Section 3.a. provided a proposed schedule with some milestones but noted that the schedule is subject to change. On July 25, 2023, PacifiCorp updated its website to inform interested parties of an update to its RFP milestone schedule indicating the selection of the final short list ("2022AS FSL") was scheduled for September 17, 2023.<sup>1</sup>

The Company wishes to inform the Commission that the date for PacifiCorp's 2022AS FSL will be delayed and will not occur on September 17, 2023. PacifiCorp will provide additional information to the Commission before the end of September.

The 2022AS RFP Milestone Schedule on the Company's website has been updated to reflect the delay in announcing a final shortlist, and the main 2022AS RFP document will be updated to be consistent with the revised schedule. The update can be found at the following link:
