ORDER TO PRESERVE RECORDS

---

ISSUED: November 21, 2023

On October 26, 2023, the Division of Public Utilities (DPU) filed a Motion for Order to Preserve Records ("Motion"), requesting the PSC issue an order directing Rocky Mountain Power (RMP) to preserve certain records pertaining to RMP's 2022 All Source Request for Proposals ("2022 AS RFP"). On November 3, 2023, the Office of Consumer Services (OCS) filed its Response in Support of the DPU's Motion. On November 9, 2023, RMP filed a response to DPU's Motion, stating RMP has no objection and requesting the PSC grant DPU's Motion.

As no party has opposed the Motion and good cause otherwise appears, the DPU's Motion is granted. The PSC orders RMP to preserve all records related to bids received in response to the 2022 AS RFP. RMP must preserve any information RMP used to (i) evaluate bids; (ii) determine a final shortlist; or (iii) otherwise determine which acquisitions would be prudent. This order to preserve records includes all: third-party bids, benchmark bids, commercial operation dates, prices, resource types, resource operating characteristics, bid terms, company communications with bidders, and internal information and communications regarding bids.

Notice of Opportunity for Agency Review or Rehearing

Pursuant to §§ 63G-4-301 and 54-7-15 of the Utah Code, an aggrieved party may request agency review or rehearing of this Order by filing a written request with the PSC within 30 days after the issuance of this Order. Responses to a request for agency review or rehearing must be filed within 15 days of the filing of the request for review or rehearing. If the PSC does not grant a request for review or rehearing within 30 days after the filing of the request, it is deemed denied. Judicial review of the PSC's final agency action may be obtained by filing a petition for review with the Utah Supreme Court within 30 days after final agency action. Any petition for review must comply with the requirements of §§ 63G-4-401 and 63G-4-403 of the Utah Code and Utah Rules of Appellate Procedure.
