EXTENSION AMENDMENT

TO

ELECTRIC SERVICE AGREEMENT

AND

OPERATING RESERVE INTERRUPTION AGREEMENT

BETWEEN

ROCKY MOUNTAIN POWER

AND

US MAGNESIUM LLC

This instrument is effective , 2021.

This extension amendment ("Extension Amendment"), amends the Electric Service Agreement and accompanying Operating Reserve Interruption Agreement by and between PacifiCorp, an Oregon corporation doing business in Utah as "Rocky Mountain Power" ("Seller"), and US Magnesium LLC ("Purchaser"). Seller and Purchaser together are the "Parties".

RECITALS

WHEREAS, on December 28, 2017 Seller and Purchaser executed an Electric Service Agreement ("ESA") whereby Seller agreed to provide electric service to Purchaser pursuant to certain terms and conditions. The ESA was approved by the Public Service Commission of Utah ("Commission") in Docket No. 17-035-71, via bench order on April 12, 2018, and confirmed by written order issued April 18, 2018. The term of the ESA was through December 31, 2018.

WHEREAS, Seller and Purchaser agreed to a one-year extension of the ESA and accompanying Operating Reserve Interruption Agreement ("ORIA"), to expire December 31, 2021. The one-year extension of the ESA and ORIA was approved by the Commission in Docket No. 20-035-47 in an Order dated March 8, 2021.

WHEREAS, on September 21, 2021, Seller filed Docket No. 21-035-53 with the Commission, requesting that the Commission set terms and conditions for electric service from Purchaser to Seller. In connection with the filing in that Docket, Seller and Purchaser have agreed to an additional extension of the ESA and ORIA consistent with the current terms and conditions as approved in Docket No. 20-035-47

NOW, THEREFOR, the Parties agree as follows:

- All terms and conditions of the Agreement as approved by the Commission in Docket No. 20-035-47 shall remain in full force and effect without claim of any interruption or lapse; and
- 2. The term of the ESA and ORIA shall be extended to and including June 30, 2022.
