On October 13, 2021, the Public Service Commission (PSC) issued its Phases I and II Scheduling Order and Notice of Hearings ("Scheduling Order") in this docket. On May 18, 2022, US Magnesium, LLC ("US Mag"), Rocky Mountain Power (RMP), the Division of Public Utilities (DPU), and the Office of Consumer Services (OCS) (collectively, the "Parties") filed a Stipulated Motion for Extension and Request for Expedited Treatment ("Motion"). The Motion proposes an amended schedule to which the Parties stipulate because they seek additional time to engage in settlement discussions. The Parties ask the PSC to vacate the remaining Phase II schedule and adopt a new schedule consistent with their stipulation.

Good cause appearing, the PSC grants the Motion and vacates the May 20, 2022 deadline for surrebuttal testimony and the hearing presently noticed for May 25, 2022. Consistent with the Parties' stipulation, the remaining schedule for Phase II is as follows:
