### STIPULATED MOTION TO AMEND SCHEDULING ORDER

Pursuant to Utah Admin Code R746-1, US Magnesium, LLC ("USMag"), Rocky Mountain Power ("RMP"), the Division of Public Utilities ("Division") and the Office of Consumer Services ("Office") file this stipulated motion to amend the scheduling order. Contemporaneously with this Motion, USMag and RMP have filed a Stipulation and Settlement Agreement ("Settlement Agreement"), along with final versions of the new Electric Service Agreement ("ESA") and Operating Reserve Interruption Agreement ("ORIA") through the Commission's confidential filing portal.<sup>1</sup> Given the Stipulation and Settlement Agreement, and agreement on a new ESA and ORIA, USMag and RMP do not intend to file surrebuttal testimony in response to the application

in this docket. Instead, USMag and RMP intend to provide live testimony at the hearing scheduled for June 22, 2022 in support of the Stipulation reached by the parties.

The Division is not a party to the Settlement Agreement but intends to support it at the hearing. The Office is not a party to the Settlement Agreement but does not oppose it. As such, the Division and Office do not intend to file surrebuttal testimony in response to the application, but desire the opportunity to address the Settlement Agreement at the hearing scheduled for June 22, 2022.

As a result of the foregoing, USMag, RMP, the Division, and the Office each hereby stipulate to amend the scheduling order in this docket to A) strike the June 17, 2022 deadline for filing surrebuttal testimony, and B) permit the parties to address the Stipulation and Settlement Agreement through live testimony at the hearing on June 22, 2022.

A proposed order approved by all parties is submitted along with this Stipulated Motion for the Commission's convenience.
