ISSUED: June 21, 2022

On June 17, 2022, US Magnesium, LLC (“US Mag”) and Rocky Mountain Power (RMP) filed a Stipulation and Settlement Agreement (“Settlement Stipulation”) in this docket. That same day, US Mag, RMP, the Division of Public Utilities (DPU), and the Office of Consumer Services (OCS) (collectively, the “Parties”) filed a Stipulated Motion to Amend Scheduling Order (“Motion”) indicating that the Parties either intend to support the Settlement Stipulation at the presently noticed June 22, 2022 hearing or do not intend to oppose it. The Parties ask the Public Service Commission (PSC) to vacate the June 17, 2022 surrebuttal testimony filing deadline and to permit the Parties to address the Settlement Stipulation through live testimony at the June 22, 2022 hearing.

Good cause appearing, and based on the Parties’ stipulated motion to amend the Phase II scheduling order, the Motion is granted. The PSC vacates the June 17, 2022 surrebuttal testimony filing deadline and grants the Parties’ request to address the Settlement Stipulation through live testimony at the June 22, 2022 hearing.
