Pursuant to the Scheduling Order and Notice of Hearing (“First Scheduling Order”) issued October 26, 2021, this docket is set for hearing on April 26, 2022 at 9:00 a.m. (“April Hearing”). On February 22, 2022, Rocky Mountain Power (RMP) filed a Settlement Stipulation (“Settlement”), bearing signatures from RMP, the Division of Public Utilities, and Interwest Energy Alliance. Although some parties to the docket have not signed the Settlement, RMP represents in the filing that none of them oppose it. The filing requests the Public Service Commission (PSC) vacate the April Hearing and set a hearing date sooner to consider evidence in support of the Settlement.

Accordingly, the April Hearing is canceled as are any remaining deadlines set forth in the First Scheduling Order that have not elapsed as of the date of this order. The PSC gives notice it will conduct a virtual hearing on **Monday, March 14, 2022 at 1:00 p.m.** to hear testimony related to the Settlement. The hearing will be conducted via Google Meet at the following link: meet.google.com/aau-kbry-euy. All parties must have their witnesses in attendance and prepared to testify.

The PSC requests that attorneys and witnesses make themselves available by both video and audio during the portions of the hearing in which they will be actively participating. Participants are free to deactivate video, and should always mute audio, when not actively participating. Participants also may find it useful to have headphones or earbuds available in the
