**Rocky Mountain Power's Notice of Intent to Use ECR Input**  
***Corrected Public Workpaper***

On December 1, 2021, Rocky Mountain Power (the "Company") submitted its Notice of Intent to Use Export Credit Rate ("ECR") Input ("Notice of Intent") in advance of the January 28, 2022 Annual Update to Electric Service Schedule No. 137 – Net Billing Service ("Annual Update"). The public workpaper that was submitted with the filing contained export profile and Energy Imbalance Market ("EIM") information. The export profile data for each fifteen-minute interval was incorrectly shifted when converting from Mountain Prevailing Time ("MPT") to Pacific Prevailing Time ("PPT"). Specifically, each interval of MPT data was incorrectly shifted by 15 minutes instead of one hour. The attached file corrects the PPT profile shift. The attached corrected Workpaper should replace the version filed on December 1, 2021 in its entirety.

In light of recent data requests, the Company has also identified the average nameplate capacity of Schedule 136 customers at the close of the historical period, which is slightly different from the average nameplate capacity at the midpoint of the historical period. While the Company is providing notice of the additional nameplate capacity information to parties, the Company continues to believe that the nameplate capacity at the midpoint of the twelve-month historical period is more representative of that period and intends to use that value in the export credit calculation.
