SECOND AMENDMENT TO

NON-FIRM POWER PURCHASE AGREEMENT

This Second Amendment (this "Amendment") to the Non-Firm Power Purchase Agreement entered into on October 11, 2019 (as amended by the First Amendment dated October 13, 2020, the "Agreement"), is entered into by and between PacifiCorp and Tesoro Refining & Marketing Company LLC. This Amendment will become effective on the date associated with the signature of the last Party to sign it. All defined terms used but not defined in this Amendment have the meanings provided to them in the definition for such terms in the Agreement.

WHEREAS, the Parties wish to extend the term of the Agreement and establish the pricing for the extension period;

The Parties agree as follows:

1. Section 2.2 of the Agreement is hereby replaced in its entirety with the following:

"Unless earlier terminated as provided herein, this Agreement shall terminate at 24:00:00 MPT December 31, 2022."

- 2. The Exhibit E attached hereto as <u>Attachment 1</u> shall replace Exhibit E of the Agreement in its entirety for the period for which the Agreement is extended by this Amendment.
- 3. The Line Loss Factor, as defined in Section 5.1, shall be 1.0206 for the period for which the Agreement is extended by this Amendment.
- 4. Except as expressly modified and amended in accordance with the provisions of this Amendment, all other terms and conditions of the Agreement remain in full force and effect and continue to bind the Parties. The Parties executing this Amendment warrant that they have the requisite authority to do so.
