*Rocky Mountain Power Reply Comments*

On December 17, 2021, Rocky Mountain Power (“Company”) filed its Application for approval of an amendment to a purchased power agreement (“Application”). The Public Service Commission of Utah (“Commission”) issued a Scheduling Order and Notice of Virtual Hearing on January 5, 2022 (“Scheduling Order”) establishing comment and reply comment deadlines. On January 18, 2022, the Division of Public Utilities (“Division”) filed comments in accordance with the Scheduling Order recommending approval of the Company’s Application.

Rocky Mountain Power hereby files reply comments in accordance with the Scheduling Order to inform the Commission and Division that a labeling error was discovered in the pricing information of the contract amendment. Specifically, the 2022 pricing shown in Exhibit E Pricing (\$/MWh), included as Attachment 1 to Exhibit A that accompanied the Application is labeled as “HLH” and “LLH”, but should have been labeled as “on-peak” and “off-peak.” All other aspects of the contract amendment, Application and workpapers are correctly calculated and labeled. For clarity in executing the pricing and terms of the contract amendment with Tesoro, LLC (“Tesoro”), Rocky Mountain Power is in the process of contacting Tesoro to obtain signatures on a corrected version of the agreement. The Company will file the corrected contract amendment with the Commission as soon as it is available.
