PETITION TO INTERVENE

Pursuant to Utah Code Ann. § 63G-4-207 and Utah Admin. Code § R746-1-108, Nucor Steel-Utah, a Division of Nucor Corporation (“Nucor”) hereby petitions for leave to intervene in the above-referenced proceeding before the Public Service Commission of Utah (“Commission”).

In support of this petition, Nucor states as follows:

1. On February 17, 2022, Rocky Mountain Power, a division of PacifiCorp, filed an application for approval of an Electric Service Agreement between PacifiCorp and Nucor.
2. Nucor owns and operates a steel mill in Plymouth, Utah, which is served by Rocky Mountain Power under an existing special contract approved by this Commission. Nucor is one of Rocky Mountain Power’s largest customers, purchasing tens of millions of kilowatt-hours of electricity per month at a cost of millions of dollars per year. Nucor’s full name and primary place of business is:

3. The current Electric Service Agreement between Nucor and PacifiCorp was set to expire on December 31, 2021, but Rocky Mountain Power extended the current ESA through February 28, 2022. Pacificorp and Nucor have agreed to a new ESA, a copy of which was submitted with Rocky Mountain Power's Application on February 17, 2022. Nucor seeks to intervene for purposes of protecting its interests, which will be substantially affected by the outcome of these proceedings, and which will not adequately be represented by any other party. Nucor's participation will promote the interests of justice. Nucor has not yet determined the specific positions it will take or the precise nature of relief it will seek. Nucor's participation will not impair the orderly and prompt conduct of the proceeding.
