NOTICE OF VIRTUAL HEARING

On March 22, 2022, the Public Service Commission (PSC) held a scheduling conference in this docket. During the conference, the parties represented their informal discussions have been productive and they anticipate filing a settlement agreement soon. The parties asked the PSC set a virtual hearing for May 16, 2022 to consider testimony in support of the anticipated settlement agreement. The parties did not see a need for filing written comments or testimony. All parties must have their witnesses in attendance and prepared to testify. Any interested person who believes additional process is warranted may file a request with the PSC, describing the additional process the party seeks and the basis upon which it is warranted.

The PSC requests that attorneys and witnesses make themselves available by both video and audio during the portions of the hearing in which they will be actively participating. Participants are free to deactivate video, and should always mute audio, when not actively participating.
