On May 4, 2023, Rocky Mountain Power (RMP) submitted a letter (“Request to Issue Public Notice”) to the Public Service Commission (PSC), explaining that it intends to hold a virtual workshop (the “Workshop”) with parties to this docket and other interested persons on June 6, 2023, at 3:00 p.m. “to discuss the seasons and hours applicable to Electric Service Schedule No. 2E – Residential Service Electric Vehicle Time of Use Pilot.” RMP and other parties agreed to participate in the Workshop as a condition of the Settlement Stipulation filed in this docket on May 4, 2022.¹

Though the PSC will not host and does not anticipate participating in the Workshop, the PSC issues this public notice that the parties intend to hold the Workshop consistent with RMP’s Request to Issue Public Notice.
