Rocky Mountain Power's Proposed Tariff Revisions to Electric Service Schedule No. 94, Energy Balancing Account

Docket No. 20-035-01

Application of Rocky Mountain Power to Increase the Deferred EBA Rate through the Energy Balancing Account Mechanism

In accordance with Utah Code Ann.§ 54-4-4 and Public Service Commission of Utah ("Commission") Administrative Rule 746-405-2(E), enclosed for filing are Rocky Mountain Power's ("the Company") proposed changes to its Electric Service Schedule No. 94 – Energy Balancing Account ("EBA"). The Company submits this filing in compliance with the Order issued by the Commission on February 26, 2021 in Docket No. 20-035-01.

Also enclosed are workpapers showing the \$36,786,109 EBA increase the Company calculated based on the Commission's adjustments in the Order. This amount includes the adjustments for the System Overhead ("SO") factor update, the removal of the replacement power costs associated with the Wyodak outage and the adjustment to reflect the full amount of the manufacturer's invoice discount associated with the Dave Johnston outage. The confidential invoices that reflect the manufacturer's discount of \$17,986.27 (total-Company) are also included with this filing.

The enclosed proposed tariff sheet is associated with Tariff P.S.C.U No. 51 of PacifiCorp, d.b.a. Rocky Mountain Power, applicable to electric service in the State of Utah. Pursuant to the requirement of Rule R746-405-2(D), PacifiCorp states that the proposed tariff sheet does not constitute a violation of state law or Commission rule. The tariff sheet reflects an effective date of March 1, 2021.
