ISSUED: July 28, 2021

On July 12, 2021, Rocky Mountain Power (RMP) filed Advice No. 21-06 (“Instant Proposed Revisions”) in this docket, proposing changes to RMP’s advanced metering infrastructure project and various changes that RMP characterizes as “housekeeping.” On July 13, 2021, RMP filed another letter designated Advice No. 21-06 in Docket No. 21-035-T08 (“Subsequent Filing”), representing “[t]hese sheets are being re-filed ... [and] replace[] the filing made on July 12, 2021, in Docket No. 21-035-T04.” The Public Service Commission (PSC) issued a Notice of Filing and Comment Period on July 14, 2021 in Docket No. 21-035-T08, and that comment period remains open through August 3, 2021.

The Instant Proposed Revisions are therefore suspended and shall not take effect by operation of statute. Unless a party requests otherwise, the PSC will take no further action in this docket. This order does not concern the Subsequent Filing and has no effect with respect to the tariff changes RMP proposes in Docket No. 21-035-T08.
