Pursuant to Utah Code § 54-10a-30 and UTAH ADMIN. CODE r. 746-101, the Office of Consumer Services (OCS) files this Motion for Permission to testify telephonically or by video conference in the upcoming hearing on Rocky Mountain Power's Application for Approval of the 2022 Energy Balancing Account. The OCS's out of state witness, Phillip Hayet, initially planned to travel to Utah to participate in the hearing in person.
