**for Preapproval of Significant Energy Resource Acquisitions**  
*Notice of Finalized Contract*

On February 11, 2022 the Public Service Commission of Utah (“Commission”) issued an Order granting the application of PacifiCorp dba Rocky Mountain Power (“Rocky Mountain Power” or “Company”) for a waiver pursuant to Utah Code Ann. § 54-17-501 and Utah Admin. Code R746-430-4. The projects for which a waiver was granted were: (i) Boswell Springs; (ii) Cedar Springs IV; (iii) Dominguez I; (iv) Green River I & II; and (v) Rock Creek II.

As a condition of its approval, the Commission required the Company to provide notice in this docket upon finalization of each of the contracts associated with the above-identified projects. Accordingly, Rocky Mountain Power hereby notifies the Commission that on April 20, 2022 it executed a power purchase agreement with Cedar Springs Wind IV, LLC, for the Cedar Springs IV wind project for a contract term of 30 years following the commercial operation date. The anticipated resource commercial operation date is December 31, 2024 for an installed nameplate capacity of 350.4 megawatts.


