On February 15, 2022, PacifiCorp (PacifiCorp) filed its confidential Semi-Annual Hedging Report ("Report"). On February 18, 2022, the Public Service Commission (PSC) issued a Notice of Filing and Comment Period, inviting comments on PacifiCorp's Report by Thursday, March 17, 2022, and reply comments by Friday, April 1, 2022. On March 3, 2022, the Division of Public Utilities (DPU) filed a request for an extension of its March 17, 2022 action request deadline to no later than April 17, 2022 and a request for a technical conference, noting that PacifiCorp made significant changes to its hedging program and that the changes are not clearly understood. The PSC subsequently granted DPU's request for time extension.
