ORDER GRANTING UNOPPOSED
MOTION TO VACATE SCHEDULE AND
NOTICE OF VIRTUAL SCHEDULING
CONFERENCE

ISSUED: March 11, 2022

On March 9, 2022, the Office of Consumer Services (OCS) filed with the Public Service Commission (PSC) an Unopposed Motion to Vacate the Schedule and set a Scheduling Conference ("Motion"). The Motion requests the PSC vacate the schedule established in the PSC's Notice of Virtual Technical Conference and Amended Notice of Comment Period issued March 7, 2022 ("Notice") and set a scheduling conference for the docket.

OCS represents several of the parties have conflicts with the date and time currently scheduled for the technical conference and discussing the matter at a scheduling conference will allow the parties to agree on a date and time that facilitates wider participation. OCS further asserts the current deadlines for initial comments and reply comments should be vacated to allow parties sufficient time to incorporate information communicated in the technical conference into their comments.
