In its comments filed April 29, 2022, the Division of Public Utilities (DPU) recommended the Public Service Commission (PSC) “order a second round of collaborative discussions to allow parties the opportunity to better understand the new hedging program and establish adequate reporting.” The PSC desires additional input from the DPU and other parties with respect to the DPU’s recommendation.
