PacifiCorp's Semi-Annual Hedging Report

SCHEDULING ORDER

ISSUED: June 22, 2022

The Public Service Commission (PSC) held a scheduling conference on June 7, 2022 for parties to discuss whether they preferred the PSC to order additional discussions related to the Division of Public Utilities' (DPU) April 29, 2022 recommendation to the PSC in this docket and, if so, specific proposals they believe should be included in an order.

As part of the hedging collaborative process held during 2011 in Docket No. 10-035-124, PacifiCorp committed to filing semi-annual hedging reports with the PSC by February 15 ("February Report") and August 15 ("August Report") each year. The DPU is tasked with reviewing PacifiCorp's semi-annual hedging reports for compliance and providing recommendations to the PSC within 30 days of the February and August Reports. During the scheduling conference, the DPU stated they will meet with PacifiCorp mid-July to discuss hedging results through the end of June 2022 reporting period. This will be an informal meeting and will not be hosted by the PSC. Individuals who wish to participate in the informal discussion should contact Jana Saba at PacifiCorp ([jana.saba@pacificorp.com](mailto:jana.saba@pacificorp.com)). PacifiCorp anticipates confidential information may be discussed and participants may be required to execute an appropriate non-disclosure agreement.

The DPU will provide a status update within 30 days of PacifiCorp's filing its 2023 February Report.
