I am providing the following in response to your e-mail request for information pertaining to PacifiCorp's Blue Sky Program. PacifiCorp does business in Utah as Rocky Mountain Power (RMP). The Public Service Commission of Utah (PSC) approved RMP's Blue Sky Program and requires RMP to file an annual report on the Blue Sky Program. This report is reviewed by the Division of Public Utilities (DPU), a state agency, and other interested parties. RMP's 2021 Annual Report of the Blue Sky Program for the January 1 through December 31, 2021 period ("2021 Report"), filed on March 24, 2022, the DPU's April 5, 2022 comments on the 2021 Annual Report ("Review"), the PSC's May 19, 2022 letter acknowledging the 2021 Annual Report, and DPU's audit of PacifiCorp's 2021 Blue Sky Program dated October 21, 2022 ("Audit") can be found at the following link: <https://psc.utah.gov/2022/03/24/docket-no-22-035-09/>.

In its comments on the 2021 Annual Report of the Blue Sky Program, DPU stated the 2021 Report "complies with [PSC] Orders and adheres to the [PSC]'s reporting requirements. In its Audit, DPU also concluded RMP "appears to be in general compliance with the rules and regulations set forth by the [PSC] Orders and adheres to the [PSC]'s reporting requirements." On December 14, 2022, the PSC acknowledged 2021 Report as complying with the PSC reporting requirements.
