On July 1, 2022, Rocky Mountain Power ("Company") filed its 2022 Net Metering and Interconnection Report for the Period of April 1, 2021 through March 31, 2022 ("Report"). On July 5, 2022, the Public Service Commission of Utah ("Commission") issued a Notice of Filing and Comment Period ("Notice") establishing a comment period for the Report. On August 1, 2022, the Division of Public Utilities ("Division") filed comments. Consistent with the Notice, the Company submits reply comments below.

In its comments, the Division recommends the Commission acknowledge the Report as meeting the reporting requirements. The Division also requests that the Company continue to provide the supporting documentation for Section 6 of Attachment C that was filed as Workpapers 1-3 with the Report. The Company agrees to continue to provide the requested information in future reports. The Division also recommends that Sections 8 and 9 be removed from future reports. The Company agrees with the Division's recommendation that the information is no longer useful since it was intended to monitor the status of Electric Service Schedule No. 136 ("Schedule 136") with regards to the program caps during the transition period. Schedule 136 has been closed to new applicants since the Commission's October 30, 2020 Order in Docket No. 17-035-61, and it is no longer necessary to monitor the status of the program caps. The Company recommends the Commission accept the Division's recommendations.


