On October 11, 2022, Rocky Mountain Power (RMP) filed with the Public Service Commission (PSC) a Request for Approval of Amendment to Electric Service Agreement with Blanding City, Utah (“Request”). Pursuant to Utah Code Ann. § 54-4-40, the Request will be statutorily approved effective **Tuesday, November 1, 2022**, unless a person the Request affects submits a request in writing to the PSC no later than **5:00 p.m., Monday, October 31, 2022**, requesting the PSC hold a public hearing or provide additional time for the person to investigate the Request.
