RE: Advice No. 22-03 Schedule 135, Net Metering Service Docket No. 22-035-T08

In its February 12, 2009, order in Docket 08-035-78, the Utah Public Serive Commission ("Commission") directed Rocky Mountain Power ("Company") to update annually the valuation of net excess generation credits for large non-residential customers in Schedule 135, Net Metering Service, to reflect the average retail rates for the previous year's Federal Energy Regulation Commission ("FERC") Form No. 1.

Enclosed for filing is the proposed tariff page associated with Tariff P.S.C.U. No. 50 of Rocky Mountain Power applicable to electric service in the State of Utah. Pursuant to the requirement of Rule R746-405D, PacifiCorp states that the proposed tariff sheet does not constitute a violation of state law or Commission rule. Also provided with this filing are Exhibit 1, which shows the calculation of the average retail rate credit prices for large nonresidential customers and Exhibit 2, which contains the data from the Sales of Electricity by Rate Schedule for FERC FORM NO. 1 Page 304, Calendar Year 2021 in State of Utah. The Company respectfully requests an effective date of July 1, 2022.
