Re: *Rocky Mountain Power's Filing in Compliance with the PSC's Order Issued on June 30, 2022 in Docket No. 21-035-53, Application of US Magnesium, LLC for Determination of Long-Term Rates, Terms, and Conditions of Interruptible/DSM Electric Service between it and Rocky Mountain Power, Docket No. 22-035-T11*

Dear Ms. Saba:

The Public Service Commission (PSC) reviewed the July 18, 2022 Tariff Compliance Filing ("Filing") submitted by Rocky Mountain Power (RMP), in accordance with the PSC's June 30, 2022 Order in Docket No. 21-035-53 ("Order").¹ The ESA approved in the Order specifies that US Magnesium will be subject to billing under Schedule 198. The Filing explains it contains revisions to Schedule No. 198, including the rate of 0.27% for Contract 2, consistent with the rate under General Service High Voltage, Schedule No. 9. RMP states the proposed tariff sheet does not constitute a violation of state law or PSC rule. RMP seeks an effective date of July 1, 2022.

The PSC also reviewed the July 28, 2022 comments and recommendation filed by the Division of Public Utilities (DPU). DPU indicates it compared the Second Revision to Sheet No. 198.2 to the Agreements and Stipulation, and explains the revisions comply with the PSC's Order. DPU also reviewed RMP's advice letter in light of Utah Admin. Code R746-405-2(D)(3)(g) and explains that it appears to comply with relevant statutes and rules. DPU recommends approval of the Filing, effective July 1, 2022.

Based on the PSC's review of the Filing and DPU's comments and recommendation, RMP's proposed Tariff revisions are approved as filed, effective July 1, 2022.

¹ The Order approved the Electric Services Agreement ("ESA"), Operating Reserves Interruption Agreement, and Stipulation and Settlement Agreement (the "Agreements and Stipulation"). In approving the ESA, the PSC thus confirmed that US Magnesium will be subject to Electric Service Schedule 198 – Electric Vehicle Infrastructure Program (EVIP) Cost Adjustment ("Schedule 198"), as set forth in Section 3.12 of the approved ESA.
