ISSUED: April 3, 2023

On March 2, 2023, PacifiCorp filed a request ("Request") with the Public Service Commission (PSC), requesting an extension to file PacifiCorp's 2023 Integrated Resource Plan (IRP) and proposing a schedule with the following deadlines: (i) PacifiCorp to file a preliminary IRP ("Preliminary IRP") with the PSC for informational purposes by March 31, 2023; (ii) stakeholders to submit comments and feedback to PacifiCorp directly through PacifiCorp's public meeting process ("Deadline to Submit Comments to PacifiCorp") by April 30, 2023; and (iii) PacifiCorp to file its final 2023 IRP ("Final IRP") with the PSC by May 31, 2023.

All stakeholders that submitted comments supported PacifiCorp's Request. Subsequently, the PSC granted the Request and the deadlines it proposed in an order issued March 28, 2023 ("Order Granting Extension").

The PSC gives notice PacifiCorp filed its Preliminary IRP on April 3, 2023.

The PSC further clarifies that its Order Granting Extension does not establish deadlines for any stakeholder, other than PacifiCorp, to make any filing with the PSC. The Deadline to Submit Comments to PacifiCorp established in the Order Granting

Extension pertains to comments to be provided directly to PacifiCorp.<sup>1</sup> After PacifiCorp files its Final IRP, due May 31, 2023, the PSC will establish a comment period for stakeholders to provide input to the PSC as it considers whether to acknowledge the Final IRP.
