PETITION FOR LEAVE TO INTERVENE OF FERVO ENERGY COMPANY

Pursuant to Utah Code Section 63G-4-207 and Rule R746-1-108 of the Public Service Commission ("Commission") Rules, Fervo Energy Company ("Fervo") hereby files its petition for leave to intervene in the above-captioned docket.

Fervo is a geothermal energy developer that commercializes technology to develop, own, and operate firm and dispatchable geothermal assets. Fervo is wholly focused on climate change mitigation and will facilitate large-scale clean power generation from geothermal resources to help reduce global emissions.

Fervo's legal rights and interests will be affected by this proceeding. Fervo is the owner of a substantial geothermal leasehold in the state of Utah and plans to bid into requests for proposals which may be announced by PacifiCorp to implement its three-year action plan as a result of its 2023 Integrated Resource Plan ("IRP"). In addition to its leasehold position and development plans, Fervo is in discussions with Utah organizations who are interested in buying power from Fervo geothermal projects. To enable Fervo to conduct analysis on the issues discussed in the 2023 IRP and provide input on the subject of projected costs and reliability attributes of geothermal energy, Fervo requests that its petition be granted.

If Fervo's petition is granted, the company will further review materials and participate in this proceeding by commenting on matters scoped for this proceeding and

requests for feedback. Fervo's participation will neither expand the scope of the proceeding nor delay the proceeding in any form or fashion.
