On May 31, 2023, PacifiCorp ("the Company") filed its 2023 Integrated Resource Plan ("2023 IRP") with the Public Service Commission. In the cover letter that accompanied the 2023 IRP, the Company indicated that the supporting information would be available on or around June 14, 2023.
