Dear Mr. Viner:

I am providing the following in response to your e-mail request for information pertaining to PacifiCorp's Blue Sky Program. PacifiCorp does business in Utah as Rocky Mountain Power (RMP). The Public Service Commission of Utah (PSC) approved RMP's Blue Sky Program and requires RMP to file an annual report on the Blue Sky Program. This report is reviewed by the Division of Public Utilities (DPU), a state agency, and other interested parties.

RMP's 2022 Annual Report of the Blue Sky Program for the January 1 through December 31, 2022 period ("2022 Report"), filed on March 29, 2023; the DPU's April 17, 2023 comments on the 2022 Annual Report ("Review"); the PSC's May 18, 2023 letter acknowledging the 2022 Annual Report; and the DPU's audit of RMP's 2022 Blue Sky Program dated October 12, 2023 ("Audit") can be found at the following link: <https://psc.utah.gov/2023/03/29/docket-no-23-035-17/>.

In its Review of the 2022 Report, DPU concluded the 2022 Report "complies with [PSC] Orders and adheres to the [PSC]'s reporting requirements."¹ In its Audit, DPU likewise concluded RMP "appears to comply with [the] regulatory and reporting

requirements," which the PSC acknowledged in its correspondence to DPU dated December 1, 2023.²

On March 27, 2024, RMP filed with the PSC its 2023 Annual Report of the Blue Sky Program for the January 1 through December 31, 2023 period ("2023 Report"). In comments submitted on April 24, 2024, DPU states that the 2023 Report "complies with [PSC] Orders and adheres to the [PSC]'s reporting requirements."
