ORDER GRANTING MOTION AND NOTICE
OF SCHEDULING CONFERENCE

ISSUED: June 30, 2023

On June 22, 2023, the Office of Consumer Services (OCS) filed a Motion to (1) deviate from Utah Admin. Code R746-315-3(3)-(6) pursuant to Utah Admin. Code R746-1-109, (2) vacate the existing notice of filing and comment period, (3) request a scheduling conference, and (4) ask for expedited treatment of the Motion. The Public Service Commission (PSC) issued a Notice Regarding Deadline to File a Response to the Motion on June 23, 2023, asking Rocky Mountain Power (RMP) and other interested persons to file any response by June 28, 2023.

On June 28, 2023, RMP filed its Response to the OCS's Motion, indicating RMP does not oppose the Motion. No other person or party filed a response.

Having reviewed the Motion and RMP's Response, the PSC finds additional time and process is warranted and in the public interest. The Motion is granted.

Consequently, the Notice of Filing and Comment Period issued on June 5, 2023 is vacated. The PSC further gives notice it will host a virtual scheduling conference on **Monday, July 10, 2023 at 1:00 p.m.** Parties should come prepared to discuss the process and adjudication schedule for this docket. This scheduling conference will be conducted via Google Meet at the following link: meet.google.com/kcd-bgcn-quw.
