At the scheduling conference the Public Service Commission (PSC) held on July 10, 2023, the parties in attendance stipulated to a bifurcated schedule, which the PSC approves and adopts.

As the parties agreed, Phase I will address Sections 1-4 of Rocky Mountain Power's (RMP) June 1, 2023 Utah Wildland Fire Protection Plan Cost and Compliance Report ("Report"), which does not include a rate request. Phase II will address Section 5 of the Report and the attendant rate request. RMP requests the rates become effective November 15, 2023. The schedule, consistent with the parties' stipulation, shall be as follows:

DISCOVERY WITH RESPECT TO PHASE I AND PHASE II

Discovery turn-around times shall be ten calendar days until August 28, 2023, and seven calendar days thereafter. Parties shall serve discovery requests and responses on applicable parties by email. In the event a document produced in response to a discovery request cannot reasonably be transmitted by email, the party disclosing the document shall provide an electronic copy of the document on CD (or, if an electronic copy is not available, a paper copy).

NOTICE OF HEARING

The PSC will conduct an in-person hearing on Phases I and II of this docket on **Wednesday, October 11, 2023, beginning at 9:30 a.m.** The hearing will be held in the **Fourth Floor Hearing Room 403, Heber M. Wells Building, 160 East 300 South, Salt Lake City, Utah.** All parties must have their witnesses in attendance and prepared to testify. If any party believes a virtual hearing would be sufficient and preferable to an in-person hearing because, for example, it would obviate the need for witnesses to travel or otherwise be more convenient and less costly for the parties, the PSC asks the party first contact other parties to inquire whether they are amenable to

stipulating to a virtual hearing. If a stipulation for a virtual hearing is reached, the PSC asks the parties file it no later than **Wednesday, September 27, 2023**.

Individuals wishing to participate in the hearing by telephone should contact the PSC two days in advance by calling (801) 530-6716 or (toll-free) 1-866-PSC-UTAH (1-866-772-8824) to receive a bridge number and participant passcode. Participants attending by telephone should then call the bridge number five minutes before the hearing, entering the passcode followed by the # sign to ensure participation.
