AMENDED NOTICE OF HEARING

ISSUED: September 29, 2023

On July 12, 2023, the Public Service Commission (PSC) issued its Scheduling Order and Notice of Hearing in this docket, setting a hearing on the merits for October 11, 2023, beginning at 9:30 a.m. The PSC was subsequently requested to present information at legislative hearings occurring at the same time and sought comments from parties regarding amending the hearing start time to 1:30 p.m. that same day. Rocky Mountain Power, the Office of Consumer Services, and the Division of Public Utilities each provided comments stating they had no opposition to the amended hearing start time. There are no other parties to this docket.

Accordingly, the PSC will conduct a hearing on the merits on **Wednesday, October 11, 2023, beginning at 1:30 p.m.** The hearing will be held in the **Fourth Floor Hearing Room 403, Heber M. Wells Building, 160 East 300 South, Salt Lake City, Utah.**
