At the scheduling conference the Public Service Commission (PSC) held on June 30, 2023, Rocky Mountain Power (RMP) requested the PSC continue the scheduling conference and refrain from further action on this docket for a period of six months, explaining the matter involves several factors that continue to develop, and the parties will be better positioned to adjudicate the application in six months. Representatives for the Division of Public Utilities and the Office of Consumer Services objected, arguing RMP prematurely filed the application.

The parties agreed they would like an opportunity to submit statements of position as to the procedure the PSC should follow and RMP's request to continue the matter for six months. The parties stipulated to the following schedule for submitting these position statements, which the PSC approves and adopts. Notwithstanding this schedule, no party has waived its right to file any motion, dispositive or otherwise, at any time otherwise appropriate under applicable rules.
