Application of Rocky Mountain Power for a Deferred Accounting Order Regarding Wildfire Claims	<u>DOCKET NO. 23-035-30</u>
	<u>NOTICE</u>

ISSUED: September 15, 2023

On June 21, 2023, Rocky Mountain Power (RMP) filed an application (“Application”) with the Public Service Commission (PSC) for a deferred accounting order relating to third-party claims stemming from Oregon wildfires that occurred in 2020. The PSC held a scheduling conference on June 30, 2023, during which RMP requested a six-month continuance. Several parties objected to a continuance, and the PSC subsequently issued a Scheduling Order requesting statements of position on the request for a continuance and the appropriate procedure for advancing the docket. RMP, the Office of Consumer Services (OCS), the Division of Public Utilities (DPU), and the Utah Association of Energy Users (UAE) filed such statements on August 11, 2023.

On August 22, 2023, RMP submitted a letter to the PSC styled “RMP’s Withdrawal without Prejudice,” indicating RMP withdraws the Application because the circumstances underlying the Application continue to develop and RMP intends to refile at a later date when the costs and impacts at issue are more fully understood. RMP’s filing further indicates it discussed the withdrawal with counsel for DPU, OCS, and UAE and each authorized RMP to state it does not oppose RMP’s withdrawal of the Application without prejudice.
