Therefore, the PSC determines it is in the public interest to close the technical conference to the public under Utah Code Ann. § 54–3–21(4) for the purpose of allowing RMP's regulators to obtain the information.

Wells Building, 160 East 300 South, Salt Lake City, Utah. Attendance at the technical conference will be limited to designated representatives of the PSC, RMP, the Division of Public Utilities, and the Office of Consumer Services. Any person
