Pursuant to Utah Code Ann. § 63G-4-207 and Rule R746-1-108, Petitioner Utah Association of Energy Users (“Petitioner” or “UAE”) hereby petitions for leave to intervene in this docket.

In support of this petition, Petitioner states as follows:

1. Petitioner is an organization that represents large Utah electric consumers who are customers of Rocky Mountain Power or whose rates are affected by Rocky Mountain Power’s rate structure.
2. This docket was opened in response to an email from Rocky Mountain Power to the Commission requesting a technical conference “to discuss PacifiCorp’s recent credit-rating change and related finance matters.” [RMP Email to Commission dated July 24, 2023].

3. The information that the Company seeks to present in this meeting is regularly utilized in proceedings before this Commission that affect the rates imposed on all customers, including those represented by Petitioner.

4. The legal rights and interests of Petitioner and its members may be substantially affected by the information to be presented in this proceeding.

5. Petitioner seeks to intervene for the purposes of protecting its interests and the interests of its members as they may appear, particularly on issues of relevance to large electric customers.

6. The interests of justice and the orderly and prompt conduct of this proceeding will not be materially impaired by allowing Petitioner to intervene.
