**WITHDRAWAL OF UAE’S OBJECTION TO CLOSED TECHNICAL
CONFERENCE**

On August 4, 2023, the Utah Association of Energy Users (“UAE”) filed an Objection to the Notice of Closed Technical Conference issued by the Commission in this docket on July 26, 2023 (“Notice”). Since filing the Objection, counsel for both UAE and the Company have conferred on the matter and reached an agreement that would allow counsel for UAE to attend the conference subject to certain non-disclosure requirements, to which counsel for UAE has agreed. The Company has submitted to the Commission a response to the Objection noting the agreement between the Company and UAE and requesting that counsel for UAE be permitted to attend the conference. In light of the Company’s letter, and based on the assumption that the Commission will permit counsel for UAE to attend the August 11 conference, UAE hereby withdraws its Objection.
