On July 26, 2023, the Public Service Commission (PSC) issued its Notice of Closed Technical Conference. On August 4, 2023, the Utah Association of Energy Users (UAE) filed its Objection to Closed Technical Conference ("Objection"). On August 7, 2023, the PSC issued its Notice Regarding Deadline to File a Response, requesting a response on UAE's Objection from Rocky Mountain Power (RMP) and any other interested person by August 8, 2023.
