The Public Service Commission (PSC) conducted a hearing in this docket on January 17, 2024. After all witnesses had testified, the parties requested an opportunity to file post-hearing briefs, and the PSC indicated it would issue a notice setting the due date to be 30 days after the hearing transcript became available.
